TRADE STAND - Terms and Conditions

- A late fee of £10 will be payable on all entries received after **Monday 8th July**
- **No trade stand can be reserved without payment.**
- BACS Details – Sort: 82 62 09, Acct: 50078010. Reference – ‘TS’ and your business name Eg., ‘TS Farm Stuff’. Please advise once payment is made. Invoices emailed on request.
- Please make cheques payable to ‘SASS Ltd’ and send with the completed form to -
Trade Stands – Sutherland Show, 2 Grant Crescent, Dornoch, IV25 3TF
- Business information will appear in the catalogue providing it is received before **Wednesday 24th June**.
- **No Hot Food** to be sold in the Taste of the Wilderness Marquee
- **Field stands must be contained within the unit space allocated.**
- Stand holders are requested to be on the show field **no later than 9am** to set up their stand.
- Stand holders must unload then **move their vehicles to the car park by 10am**.
- Vehicles of outdoor stand holders can be parked on the stand, providing they fit within the stand boundary, but must not be moved during show opening times.
- All other vehicles must be removed to the car park before 10am, including those of Craft/Trade Marquee traders.
- All stand holders must agree to observe the Health and Safety Rules displayed on the show ground. Please ensure you carry out a suitable risk assessment that includes any risks to the public, staff or show volunteers. A template can be found on our website.
- Passes – The following entry passes will be issued in the week leading up to the show
Outdoor Field Stand – 3
Indoor Trade Tent – 2
Taste of the Wilderness – 2
1 extra pass will be issued to those taking double stands.
Any further pass requests will be charged at the full rate of £8.
- Details of all stand holders selling food will be notified to the Highland Council Environmental Health Office, Golspie. Please bring any relevant safety permits with you for inspection.
- All traders are to accept the stand position they are allocated. Anyone setting up in a different position will be requested to move.
- There will be only 2 free charity stands available which will be chosen at the discretion of the committee.
